

Executive Director's view

Christian Lambrech The past few months have been marked by the achievement of significant milestones, consolidation of our expanded conservation portfolio and an improvement in Rhino Ark's international visibility.

Our fencing initiatives are progressing well. In Mau Eburu, over 50% of the 50-kilometre fence has been built since the project commenced in March 2013. The northern boundary of the forest is now completely fenced. In Mt. Kenya, construction of the 53-kilometre long Phase One section that spans the area between Kiringa and Thuchi Rivers is nearly complete, accounting for over 11% of the projected 450-kilometre total length. In the Aberdares, rehabilitation of Phase One section along the Eastern Salient of the National Park has commenced. The 38-kilometre phase that was completed in 1992 has now outlived its intended lifespan. The rehabilitation will extend the fence lifespan by another 20 years. This investment underscores Rhino Ark's long-term commitment to conservation of the Aberdare ecosystem and to providing sustainable solutions to the challenges facing Kenya's water towers.

Our expanded programme is getting firmly established. Seven joint aerial reconnaissance flights have already been conducted above Mt. Kenya and the Aberdares. The quarterly flights are an important tool to support the management of these mountains. The environmental curricula for primary and secondary schools around Mau Eburu have been developed and are being implemented in over 30 schools.

Rhino Ark continues to support the war on wildlife crime by facilitating appropriate capacity building for partners KWS and KFS. Tactical training was provided to 50 rangers from KWS and KFS with the support of the British Army Training Unit Kenya. In addition, we also facilitated training in the prosecution of wildlife crimes to 19 KWS wardens in collaboration with KWS and Space for Giants.

With the support of our Rhino Ark United Kingdom office, a parliamentary reception was organized at Westminster Palace in December 2013, on the importance of Kenya's water towers and the successful conservation approaches of Rhino Ark in addressing the challenges facing them. The event was also designed to provide new fund raising opportunities. A positive outcome of the event has enhanced visibility for Rhino Ark in the international media, including The Independent, The Guardian, the New York Times, as well as Kenya Airways' in-flight magazine Msafiri.

Eburu bioenterprise initiative: Honey production steps up

The Eburu Bioenterprise honey production initiative is geared towards enhancing the capacity of local farmers to produce and market high quality honey as an income generating activity (IGA). Providing forest adjacent local communities with skills and opportunities to engage in non-destructive IGAs is an effective long term strategy to reduce unsustainable dependence on forest resources.

Stage 1 of this initiative involved providing basic training in bee keeping best practices to selected Eburu community groups, and was conducted in 2012/13.

Stage 2 of this process has now commenced, starting in January 2014. It was facilitated by a bioenterprise consultant engaged by Rhino Ark and involved the following activities:

- Audit of current honey production by farmers in the Eburu ecosystem;
- Assessment of local pricing for raw honey and a survey of bulk produce prices for competing bee keeping enterprises in neighbouring sub-counties;
- Practical training on semi-processing techniques to honey production groups;
- · Collection of semi-processed honey samples and presentation to potential bulk
- · Assessment of the honey market and identification of potential bulk buyers from Nairobi and Naivasha towns.

A key outcome observed from this process was the 29% increase in number of hives since May 2013.

Current knowledge gaps of the local community in honey production were identified. 28 local community members from various groups received training in honey semi-processing methodology. Discussions with bulk honey buyers that were presented with Eburu honey samples indicate that there is potential for good sales.

Rhino Ark will continue to work with the Eburu communities as well as other stakeholders to further develop the bioenterprise honey production initiative.

Eburu Secondary School receives curriculum books

Conservation education programme kicks off in **Eburu schools**

Teaching of the newly developed conservation education curricula has kicked off in 32 Eburu schools in the January 2014 school term. The comprehensive curricula for both primary and secondary schools aim to provide pupils with essential environmental conservation knowledge and skills. The lessons contained in the curricula provide relevant content for pupils from Class Four in primary school, all the way to Form Four in secondary school.

The curricula are contained in 4 books developed by Rhino Ark in partnership with the Ministry of Environment, Water and Natural Resources and the Ministry of Education. Environmental education teachers in each of the schools were in late 2013 trained on the curricula in preparation for the roll out in the New Year.

This initiative by Rhino Ark marks a distinctive step forward for conservation education: it brings together relevant knowledge from diverse areas and packages it into a harmonized form that can be taught to school children in a systematic manner. It facilitates continuous and consistent learning through the mid-primary to secondary school academic life of pupils, and in so doing, provides a solid foundation for them.

Eburu fence: 50% completed

A major milestone has been achieved in the Rhino Ark project to conserve Eburu forest: 25 of the projected 50 kilometres of the electrified fence have now been constructed since the project commenced in March 2013. The fence is being built along the gazetted Eburu Forest Reserve boundary. It stretches westwards from 'Fire Tower' in Eburu Location, through Ole Sirwa and Morop areas of Ol Jorai Location, traverses steep-sided valleys in Kahuho area, curves sharply east at Gachuma Centre in Kiambogo Location and onwards to Centre One in Ndabibi location.

Fence construction work is being undertaken by a crew of up to 32 team members, comprising a mix of experienced technicians from Rhino Ark partner Kenya Wildlife Service, and labour drawn from the local community. A standing Fence Technical Committee comprising project partners Rhino Ark, Kenya Forest Service and Kenya Wildlife Service meets monthly on site to assess the work done. The committee ensures the quality of work by physically walking the most recently completed section of fence line, inspecting every metre of the fence built, and addressing any technical issues that impact on the fencing work.

Governance of the project is supported by a Fence Management Committee constituted for this purpose. This committee comprises top management of the three partner organizations, and exists to provide corporate level support and quidance to the project.

One year has passed since commencement of construction, and with 50% of the fence now completed, clear impacts are beginning to emerge. Farmers adjacent to fenced areas are protected from wildlife. Illegal activity in the forest has declined sharply, and the forest management has seen a doubling of revenues from forest user groups due to better control of access into the forest.

At the present rate of construction, it is anticipated that the fence will be completed by the end of the year.

First Eburu fence energizer house commissioned

Friday 28th March marked another milestone in the Rhino Ark Eburu fence project, with the commissioning of the Morop fence energizer house in Ol Jorai Location. The chief guest at the event was Francis ole Nkako, Acting Managing Director of the Kenya Water Towers Agency.

The well-attended event was organized by Rhino Ark with core project partners Kenya Forest Service and Kenya Wildlife Service. Senior officials of Nakuru County, members of the local community, friends of Rhino Ark, key project donors (MPESA Foundation and Finlays), conservation partners, administration and law enforcement officials convened at the venue to participate in the event.

The Nakuru County was represented by Deputy Governor, Joseph Ruto, Environment Minister Prof. Richard Rop and Member of County Assembly Jane Simita. The Ministry of Devolution and Planning was represented by Senior Director of Administration Hassan Noor Hassan, MPESA Foundation by Executive Director Les Baillie, and Finlays by Managing Director Simeon Hutchinson.

The energizer house was built at a cost of KES. 6.6 million, with funding support from the MPESA Foundation. It is a multi-purpose facility housing the system that powers a 20 kilometre section of fence and also acts as the base for the fence scouts that maintain the fence. The facility is the first of three of this type that will be constructed along the Eburu fence line.

Top enforcement officers and county administrators visit Eburu fence

Rhino Ark together with partner Kenya Forest Service organized an orientation field visit to the Eburu fence for 6 senior law enforcement and administration officers on 13th March 2014. The officers were drawn from divisions within Nakuru County that are adjacent to Eburu forest. Officers that attended included the Deputy County Commissioner (Gilgil Division), Assistant County Commissioner (Elementaita), Assistant County Commissioner (Gilgil), Officer Commanding Police Division (Gilgil), Officer Commanding Police Station (Elementaita), and Officer Commanding Police Station (Kongoni).

The purpose of the field visit was to introduce the officers to the Eburu project. The guests were provided with a detailed project briefing and useful material on the Eburu Ecosystem Conservation Project. The officers visited selected illegal forest activity hot spots to appreciate the challenges involved in protecting the forest, and had the opportunity to network with members of the project team.

Many conservation challenges facing Eburu forest have their roots in illegal human activities, and the cooperation and support from local law enforcement and administration is often a critical success factor in addressing these challenges.

The field visit provided a good foundation for enhanced future collaboration between law enforcement officers, administration officers and the project team.

Fence build progress

Phase One of Mt. Kenya fence is nearly completed. As of 18th March 2014, approximately 49 kilometres of comprehensive fence have been built, as well as 2 kilometres of two-strand fence to protect forest plantations. Phase One (53 km between Kiringa river – Thuchi river) is expected to be completed by the end of April 2014.

Preparation for the building of Phase Two is well underway and Procurement of fence material has been done.

The Mt. Kenya Electric Fence is now protecting some 20,000 camphor trees (Ocotea usambarensis) planted in the late 1940's near Irangi Forest Station. Over the past decades, illegal logging has been the main threat to this plantation of hardwood indigenous trees. The newly erected electric fence will assist KFS and KWS in addressing this menace.

Engaging the communities and their leaders in conservation

Rhino Ark, together with KWS and KFS organized a Community Leaders Sensitization Workshop on 12th November 2013. The workshop was attended by over 70 leaders from all the communities adjacent to Phase Two of the Mt. Kenya Electric Fence that will start in early May 2014. The workshop aimed to sensitize the leadership on the importance of Mt. Kenya Forest, the benefits and management of the fence and other conservation issues. Participants included the Deputy Governor, DCs, DOs, Chiefs, Assistant Chiefs, CFA chairpersons, opinion leaders, womens' group leaders and youth group leaders. Towards the end of the workshop, the leaders fully endorsed the building of the fence and committed themselves to:

- a) Provide leadership in environmental conservation;
- b) Sensitize the communities on the importance of Mt. Kenya Forest, the benefits of the fence, its construction and its management.

Following the Workshop, Rhino Ark, together with KWS, KFS and the local administration held public meetings (barazas) in the twelve locations bordering Phase Two of the Mt. Kenya Electric Fence between 24th March 2014 and 4th April 2014. The barazas aimed to sensitize the communities on the building and maintenance of the fence, the management of fence gates and the need to protect the forest. The barazas also helped air issues related to the management of the forest.

Addressing illegal activities

To identify and help address the threats to the conservation of Mt. Kenya, three surveillance flights were carried out on 3rd July 2013, 15th September 2013 and 13th March 2014. They covered the forests in Kirinyaga, Embu, Tharaka-Nithi and Meru Counties. During the flights, low levels of recent human disturbance were observed. A number of law enforcement interventions have already been conducted by KWS and KFS to address the illegal activities observed during the flights.

The flight carried out on 13th March enabled assessment of the efforts conducted by KFS to rehabilitate the Lower Imenti forest. That forest was invaded by *Lantana camara* – a highly invasive plant species from the American tropics - after the

eviction of squatters in 1999 [left photograph]. KFS entered into an agreement with neighbouring farmers by which they are allowed to plant annual crops in the forest for a period of three to four years in exchange of which the farmers have to uproot the invasive lantana, plant young indigenous trees and care for them.

Enhancing patrols on Mt. Kenya

Towards enhancing the ground patrols by KWS, Rhino Ark is implementing a state-of-the-art patrol monitoring system on Mt. Kenya. The system will comprise of two main components: (a) advanced GPS devices with in-built camera and SIM card to be used by the six patrol teams on Mt. Kenya; (b) a central mapping server to be based at KWS HQs that will receive data from multiple GPS devices and display the data in real time in a mapping environment that will be accessible to the senior managers.

To reduce the purchasing cost of this system, Rhino Ark applied to the ESRI Nonprofit Organization Program to acquire ArcGIS software for a nominal administration fee in July 2013. On 3rd September 2013, Rhino Ark was notified by the ESRI East Africa Office that the application was granted. Through that grant, a saving of approximately USD 55,000 over the commercial rate has been realized.

The setup of the server is completed and the training on the multiple modules of the system is near completed. The system is expected to be operational towards the end of April 2014.

Rehabilitation of Phase One started

Rhino Ark has begun a rehabilitation programme to upgrade and update part of the fence surrounding the Aberdare ecosystem. The first phase of the Aberdare fence, along the Eastern Salient of the Aberdare National Park, was completed in 1992. The 40-kilometre of the section has now outlived its projected lifespan, as has the 40-kilometre of the second phase, which was completed in 1995.

The rehabilitation of Phase One of the fence began in January 2014, starting with the seven kilometre section between Mitero Gate and Wandare Gate. This segment is one of the most vulnerable sections of the Salient fence and its rehabilitation, which is expected to extend the fence's lifespan by 20 years, will be finished during April 2014. In support of the rehabilitation work, Rhino Ark has already provided 1,400 new fencing posts along with additional funds to cover the expense of fencing equipment and materials and the extra running costs for vehicles used in the rehabilitation programme.

The rehabilitation of Phase One underscores the long-term commitment of Rhino Ark to the conservation of the Aberdare ecosystem.

Addressing illegal activities

Rhino Ark is conducting quarterly surveillance flights above the Aberdare forests, together with KWS and KFS.

On 18th November 2013, a surveillance flight was conducted with a team of six field managers from KWS, KFS and Rhino Ark. The flight enabled an assessment of the impact of recent interventions to address illegal activities in the Northern Aberdares. Major improvements were observed in one of the two hot spots detected during the surveillance flights carried out in February and April 2013. Further interventions will still be required in the other hot spot. The flight also covered forest areas in Nyeri and Muranga counties.

On 24th March 2014, another surveillance flight was conducted covering the western side of the Aberdare range spanning the counties of Nyandarua and Kiambu. The flight also covered Mount Kipipiri and revealed low levels of human disturbance in the forest. However, it enabled the detection of one emerging issue near South Kinangop Forest Station. During the debriefing after the flight, the team agreed on a response to address the issue.

Rhino Ark presented an award to Teacher Magdeline Wanja of Njogu-ini Primary School at a ceremony held at the school in January 2014. She emerged the Best Overall in the Aberdare Fence Essay Competition 2013. Eighty seven teachers drawn from Primary schools bordering Rhino Ark Aberdare fence entered in the essay competition. The essay was entitled 'Discuss ways to enhance conservation education in your school'.

Aberdare Fence Essay Competition is an annual activity organised by Rhino Ark and Kenya Wildlife Service aimed at engaging pupils drawn from fence-line community in a

competitive process that is used to select schools to participate in the Annual Aberdare Fence Relay Run. The Fence Run aims at raising awareness among the local community on the need to own the 400km Aberdare fence so that they can continue enjoying benefits accruing from the fence.

The prize-giving ceremony was graced by the Deputy County Commissioner, Tetu North. Local leaders, clergy, teachers, parents and pupils cheered as Teacher Magdaline was crowned the winner of Aberdare Fence Essay Competition 2013 in the teachers' category. Certificates were also presented to the participants of Aberdare Relay Run 2013.

Collaboration with BATUK

Rhino Ark is coordinating the support by the British Army Training Unit Kenya (BATUK) to KWS and KFS in the Mt. Kenya/Aberdare area. The support includes provision of training and the rehabilitation of key infrastructure in both mountain ecosystems.

On 3rd - 5th December 2013, a tactical training was provided by the 3rd Battalion of the Parachute Regiment (3rd PARA) to 20 KWS rangers and 30 KFS rangers near Nanyuki Forest Station.

Through BATUK, an expert from the London Fire Brigade was provided to help draft an Emergency Response Plan for both Mt. Kenya and Aberdare ecosystems. The plan, once completed, will help secure a prompt and coordinated response to address, among other issues, wildfires on Mt. Kenya and in the Aberdares.

With the support of BATUK, the rehabilitation of Nanyuki Bridge has been successfully completed. The bridge is the first among the eight key infrastructure components identified in Mt. Kenya and Aberdares to be rehabilitated with the support of BATUK.

Rhino Ark, together with KWS and Space for Giants, organized a two-day training programme on the administration of justice to address wildlife crimes. Participants included 18 KWS wardens from Mt. Kenya, Aberdares, Mau Eburu, Laikipia and Samburu areas. Mount Kenya Trust also participated in the training.

The purpose of the training was to address weaknesses in the prosecution of wildlife crimes, that were identified during the Retreat for Magistrates that was organized last year in Meru National Park. The training focused on: 1) the trial process; 2) drafting of charge sheets; 3) handling of evidence; 4) recording of witness statements; and 5) the Court Users Committee. It also covered the new 2013 Wildlife Conservation and Management Act. The training was given by Stephen Githingi, Thomas Muraguri and Florence Macharia, all three magistrates and Mike Muya, public prosecutor who provided their time and expertise pro bono.

Importance of protecting Kenya's water towers highlighted at parliamentary reception in London

The critical importance of Kenya's water towers was addressed at a reception in the House of Lords which was hosted by Rhino Ark Patron Lord Aberdare on behalf of the Rhino Ark. The reception was held in the River Room, by gracious permission of the Lord Speaker, on Tuesday, 10th December.

The event, held during the week that Kenya celebrated its 50th anniversary of independence, highlighted Rhino Ark's important work in the country, in partnership with the Government of Kenya. The High Commissioner of Kenya, H.E. Mr Ephraim Ngare, attended the reception, along with parliamentarians, members of the business community, Friends of Rhino Ark and other environmental organisations. The event was sponsored by Pax Mondial.

The purpose of the reception was to: (1) raise the profile of Kenya's water towers as critical natural assets supporting Kenya's economic development, human well-being and ecological stability; and (2) show case the successful conservation work carried out by Rhino Ark to address the challenges facing these ecosystems, in particular human-wildlife conflicts, forest degradation and wildlife poaching.

Greening Rhino Ark's Aberdares Operation Base

As part of the greening of its operations, Rhino Ark has installed a solar power system in its operation base in the Aberdare National Park, known as the "Rhino Retreat". Nine solar panels of 250 watts each are now powering the base, together with a state-of-the-art charger-inverter. The system was installed by Chloride Exide Kenya Ltd.

The benefits of the solar system include:

- a) Provision of electricity 24 hours/day, instead of 4.5 hours/day, to the Rhino Retreat, making it a much more effective operation base for Rhino Ark management, and more comfortable retreat for Rhino Ark's guests;
- b) Reduction of fuel consumption by approximately 1,490 litres/year that were used for the running of the generator;
- c) Show case of the use of solar energy to power individual houses; and, $\,$
- d) Elimination of the burden on guests to carry jerry cans of fuel to the Rhino Retreat.


